Background

World Health Partners (WHP) is a non-profit organization mandated to deliver holistic healthcare to underserved communities by innovatively leveraging available resources more efficiently. Evidence-based management and technological solutions that are sophisticated to work in extremely low-resource settings are the hallmarks of WHP's programming strategy. WHP believes that it is unconscionable to divide resources on ideological basis—such as public and private sectors—since low resource settings mandate a focus on collectivizing all existing resources to achieve better outcomes.

WHP is best known for its programs focused on early detection and treatment of tuberculosis in urban and rural settings supported by community-based activities to ensure prevention. WHP currently operates its projects in Bihar, Jharkhand, Uttar Pradesh, Punjab, Haryana, Uttarakhand, Himachal Pradesh, Gujarat and Delhi.

About the project

WHP has been selected as a Sub Recipient (SR) of Karnataka Health Promotion Trust (KHPT) for implementing the **IMPACT India project** supported by The Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM), for the grant cycle 2024-2027, for the TB grant in India. WHP will implement this project in selected districts of Delhi, Uttar Pradesh, Himachal Pradesh and Uttarakhand. The key project elements include TB Champion Engagement and TB Mukht Gram Panchayat activities. The project activities will be implemented in close collaboration with state and district NTEP, Panchayat Raj and Rural Development and other allied stakeholders.

The project's implementation geography in a state involves two primary interventions, TB Mukht Gram Panchayat (TBMGP) and TB Champion (TBC) Engagement, organized as a cluster of districts. One district will host both interventions in this structure, while the remaining districts will solely focus on TBC Engagement. The District Coordinator - TBC engagement will be located in the TBC engagement-focused district headquarters and will be responsible for the implementation of the intervention in the district.

Scope of work and key responsibilities

Key Responsibility Areas (KRA) would include but not be restricted to the following:

- Function as point person for the project in the assigned district on behalf of World Health Partners.
- Function as Head of Operations for all project activities in the district which includes implementation and direct supervision of block/mandal level staff, if any.
- Responsible for the TBC engagement project deliverables in the district and the clustered districts.
- Act as a communication channel between the State Implementation Lead and the NTEP for the TBC engagement activities.
- Ensure the coordination with the respective District TB Office with respect of the project activities.
- Ensure the documentation and reporting at the district level and ensure the same is updated to the State Lead on a weekly/monthly basis.
- Support the training activities planned for the TBCs, District Nodal Officers, CHOs, and staff.
- Ensure the planned activities are implemented on time with the expected results envisaged in the project.
- Coordinate meetings at the District/TU level for the TBC engagement intervention.
- Day-to-day coordination with Community Coordinators/NTEP team/HWC for follow-up of the activities conducted/planned.
- Ensure regular (daily/weekly/monthly) monitoring of data.
- Attending/conducting coordination meetings with Line departments (District/Taluk/Block/Mandal) for the support required for the project implementation.
- Prepare District presentations on the performance and submission of reports to the line manager.
- Ensure Consolidation of the Report at the district level and uploading to the website/Support to any survey team deputed by WHP and KHPT.
- Support the PMTB MBA activities as per the guidance from the cluster/state lead.
- Perform other relevant duties aligned with the project objectives as required by the WHP

Note: The principal responsibilities listed above are an illustrative list and not an exhaustive list. Additional responsibilities may be added from time to time depending on Project requirements.

Qualifications, Experience, and Skills

- Master's degree in social work, sociology, or public health, in a relevant discipline with minimum 5 years of experience, or Graduates in a relevant discipline with substantial years of experience.
- Should be a competent candidate experienced working in the field of TB, and HIV Care and support with key/vulnerable populations.
- Willing to travel extensively to all the villages, and spend quality time with the beneficiaries.

- Two-wheeler with driving licence is must for this position as the position demands 10-14 days travel in the villages, wherein public transport is nil/limited.
- Fluency in written and spoken English and local language and computer skills is desirable.
- Self-motivated and able to motivate others.
- Commitment to public health values and TB control.
- Commitment to quality work by self, by team.
- Must be good in interpersonal communication and must be excellent in the local language.
